- lessons will be available to the repeaters on payment of Rs. 150/- per set after producing registration fee receipt.

## 13) Scholarship/Free ship

## (SC, NT, DT, SBC & OBC Students for all courses) Eligibility for Scholarship / Freeship Only

- Scholarship for SC Category Family annual Income Limit should be up to 1,00,000/-.
- OBC/NT/DT/SBC Category Family Annual Income limit must be between 49,000/- to 65290/- (50%) Scholarship.
- OBC/NT/DT/SBC Category Family Annual Income limit must be up to 49,000/- (100%) Scholarship.
- Students from OBC/NT/DT/SBC Category Income above 65,290/- will get Freeship.
- The students from other than Maharashtra state are not eligible for Scholarship / free ship schemes.(other state Eligibility case)

The candidates who want to claim free ship should submit. The following documents at the time of admission.

## 14) Procedure for applying

- Printout of The filled application form of freeship should be submitted to CDE office with the registration form of respective course.
- Students should submit all the documents as per the information given in the online form.

#### Document to be submitted with freeship/scholarship form:

✓ One copy of the passport size photograph with signature of the candidate thereon (for fresh scholarship)

- ✓ One attested copy of certificates, Diploma, Degree etc. in respect of all examination passed.
- ✓ One attested photocopy of Caste certificate issued and duly signed by an authorized Revenue Officer not below the rank of Tahsildar.
- ✓ An Income declaration by the parents / guardians / own stating definite income from all sources of last year
- ✓ Income Certificate from Tahsildar or Form No. 16 A (As per Circular number 1749 Dated 14-6-2008 By Spl. District Social Welfare Officer, Mumbai Suburban.
- ✓ Non Creamy layer Certificate for VJ / NT / OB / SBC.
- ✓ Gap Certificate if there is gap in education.
- ✓ Residential proof Ration card (Compulsory).
- ✓ District change Certificate in case any candidate change his district.
- ✓ Death certificate in case father / mother expired.
- ✓ Any other documents which is mentioned on <a href="https://mahaeschol.maharashtra.gov.in">https://mahaeschol.maharashtra.gov.in</a>
- ✓ A receipt in acknowledgement of the scholarship in the previous year on the form attached to the application only duly countersigned by the Head of the Institution concerned, if the application was in receipt of a scholarship under this scheme in the preceding year.
