### Ph.D. Entrance Test (PET) - 2024

Online Applications are invited by the Shreemati Nathibai Damodar Thackersey Women's University, Mumbai from eligible candidates for admission to Ph.D. programme in the University Departments & Recognized Research Centres / Institutes.

### Candidate shall be admitted to Ph.D. programme through two stage process:-

- Ph.D. Entrance Test (PET), which shall be a qualifying test. The Entrance Examination will be of 100 marks with multiple choice type questions.
- ii. Personal Interview of candidates qualifying in Entrance Test/Candidates exempted from Entrance Test, to be conducted as per procedure prescribed in due course.

Candidates with M.D./M.S. qualification will be considered eligible to Ph.D. Program in the Subject equivalent to medical science under the faculty of Science and Technology.

ii. Qualification of CA/CS/ICWA shall be treated as Post-Graduate qualifications in the Faculty of Commerce & Management.

#### C. Exemption from appearing in Ph.D. Entrance Test:

The Candidates fulfilling at least one of the following conditions will be exempted from Entrance Test:

- Candidates qualified in UGC-NET/NET-LS/SET(Maharshtra)/GATE (valid Score) /JRF/GPAT examination of apex bodies such as CSIR/ ICAR/ ICMR/UGC/DET/CEE, AICTE and similar National Level Tests will be exempted from the Entrance Test but will be required to appear for personal interview at the respective departments.
- Candidates who have completed M.Phil Programme in a relevant/allied discipline(s) ii. from a UGC recognized University/ Institute will be exempted from the Entrance Test but will be required to appear for personal interview at the respective departments.

- ✓. Scanned copy of the Medical Certificate issued by Civil Surgeon in case of persons with Disabilities (P.H.) candidates (if applicable).
- ✓ Scanned copy of certificate issued by Divisional Deputy Commissioner, Women & Child Development Department, Government of Maharashtra for Orphan candidates (if applicable)
- Required documents for exemption from written test: Candidate shall upload following documents along with Online Application:
- Scanned copy of UGC-NET/NET LS/SET(Maharshtra)/GATE (valid Score) /JRF/GPAT examination of apex bodies such as CSIR/ ICAR/ ICMR/UGC/DET, AICTE and similar national level tests qualified certificate.
- Scanned copy of M. Phil. Marksheet and Degree Certificate.

### General Instructions:

 Candidates who are in the final year of the qualifying examination of the course are allowed to apply for the PET. However, the admission of such candidates is subject to their passing the qualifying examination.

- Admission to any program does not guarantee hostel facility or any kind of iii. financial support in any form like Scholarship, fellowship, Earn and Learn etc. The University has independent procedures for offering such benefits.

If at any stage that a false claim has been made by the candidate or the important material facts have been concealed and / or the candidate is not eligible, her candidature shall be liable for cancellation at any stage.

- Admissions are completely depend upon an availability of Research Centre and xiii. Research Guide.
- The online link for submitting PET application will be closed at midnight of xiv. 23.08.2024. No request will be entertained thereafter.

- xv. Hall Tickets OR Email will be issued online to all candidates, who have applied for PET-2024.
- xvi. The Ph.D. Entrance Test will be conducted in English and as per the mediums available for that subject for all four faculties except for subject Marathi, Hindi, Gujarati etc.
- xvii. Fees once paid will not be refunded in any case.
- xviii. Candidates are advised to refer the University website <a href="www.sndt.ac.in">www.sndt.ac.in</a> for all types of information. No personal communication will be sent to candidates.
  - xix. PET will be an eligibility condition to apply for an admission to a Ph.D. Programme. However, it shall not ensure such an admission for Ph.D. as the case may be.
  - xx. Revaluation and Photocopy facility for PET is not allowed and request for the same will not be accepted.
  - xxi. The documents provided by the students along with PET examination application should be submitted by the candidates at the time of Interview. If the said documents are not submitted the admission will be considered as cancelled.
- xxii. Admission will be confirmed after verification of original documents by the concerned Research Centre concerned.
- xxiii. The online exam of PET- 2024 will be in jurisdiction of SNDT Women's University only.
- xxiv. Candidates are requested to follow NET syllabus incase if PET syllabus is not updated on SNDT Women's University website.
