I am forwarding herewith the proformas for applications to be submitted for following types of affiliations granted for the academic year 2022-2023:

- (1) Form "A" to be filled by all Applicant Institute
- (2) Form "B" Genral information to be filled by all applicant Institute for Continuation of Affiliation
- (3) Form "C" for Extension of Affiliation for **the Subjects of Natural Growth**

As per Section 109 of the **Maharashtra Public Universities Act, 2016**, the affiliated Colleges, which have been granted First Time Affiliation to conduct Course/Courses of study are required to apply for Continuation of Affiliation for such Course/ Courses of study.

The Concerned affiliated Colleges are requested to note the same and send the proposals for Continuation Permanent / Natural Growth of Affiliation, **giving all requisite information** in the **prescribed form**, irrespective of type of affiliation.

It may be noted that if the temporary affiliation is granted by the State Government / University, the said Trust on completion of 5 years of affiliation, has to apply for NAAC accreditation failing which their affiliation will be automatically cancelled. However, if they have applied for NAAC accreditation a copy of the form be submitted for consideration. It may be noted that all the documents as per GR of 30.10.2010 be sent to the University alongwith proposals failing which such proposals will not be considered. The said GR is available on the Government of Maharashtra website www.maharashtra.gov.in

In case of any difficulty in filling up the proforma or any suggestions for improvement and simplification, the same may be communicated to the **Assistant Registrar/Office , Affiliation Section, S.N.D.T. Women's University, Mumbai-20**, urgently through the email Id- affiliation@sndt.ac.in.

Separate proposals for each type of affiliation in Separate files with form & documents, along with the requisite fees for each affiliation, should reach this office on or before **September 30th 2021**. The Demand Drafts towards the affiliation fee be drawn in favour of "**The Registrar, S.N.D.T. Women's University, Mumbai**" payable in Mumbai. The College may refer to the fee schedule for different types of affiliation on web site :- www.sndt.ac.in

This is to bring to your notice that the colleges which have been granted **Permanent Affiliation** are requested to send applicable **Annual fees without filling up any Form**.

All Principals are hereby directed to send the required forms alongwith the fees on or before **30.09.2021**, failing which the **penalty of 20%** will be levied on the total amount due by your college upto **30.11.2021** & failing which the **penalty of 30%** will be levied on total amount due by your college upto **31.12.2021**. If the particular college fails to pay the said fees (alongwith penalty) up to **31.12.2021** the process of withdrawing the affiliation for the said course will be processed.
