CIRCULAR

This is in partial clarification of the University Circular No. Exam/U.G.-P.G./2020-2021/Convid-19/2020-2021 dated 4th July 2020, about the revised dates of the events related to the examinations of the Post-Graduate Degree and Diploma Programmes (Regular and Distance Education Fresh candidates).

All the concerned are hereby requested to note that, as mentioned at Serial No. i of the University Circular dt. 4th July 2020, as referred hereinabove, the concerned Colleges and University Departments should upload on the digital University portal, only the marks obtained by the students in the Internal Assessment/ College Assessment (Theory and Practical) of the current semesters, other than the final semesters (in case of Semester Pattern Programmes) and final year (in case of Annual Pattern Programmes). Further, such Colleges and University Departments need not conduct the University Practical Examination (External Assessment -Practical) nor should the marks obtained by the students be uploaded on the digital University portal, in case the University Practical Examination (External Assessment-Practical) has already been conducted by the concerned College and **University Departments**. However, in case of courses of studies/papers, where the 100% University Practical Examination (External Assessment - Practical) is prescribed, the colleges and University Departments offering such programmes will be required to conduct the University Practical Examinations (External Assessment - Practical) as per the directives of the University issued vide circular dated 2nd June 2020.

All the concerned are therefore requested to note that, the afore-mentioned University Circular dt. 4th July 2020 has been accordingly amended as stated in the paragraph-2 above and take suitable action at their end and carry out the events related to examinations as per the Time Schedule as mentioned in the Circular dt. 4th July 2020 and do the needful in accordance with the directives issued under the earlier circular dt. June 02, 2020, as the case may be.
