As per the aforesaid circulars, all the concerned University Departments / University Institutions / Conducted and Affiliated Colleges were informed that, the Theory Examination Fee / 25% Administrative Charges / Practical Examination Fee / Internship Fee / Dissertation Fee / Passing Certificate Fee / Convocation Fee / Project Fee / Examination Fee and other Fees as applicable for the U.G. and P.G. degree and Diploma Programmes (Semester / Annual Exam Fees) for the academic year 2018-2019 and 2019-2020 as per the number of students appeared for the Fresh / Repeaters / ATKT Examinations must be remitted to the University before the commencement of the respective examinations which were held in October / November / December, 2018 and March / April / May / June, 2019 and October, 2020.

As per the directives of the Hon. Vice-Chancellor, S.N.D.T. Women's University and the observation made by auditors from the office of the Auditor Government of India, the Principals of the concerned Colleges (both affiliated and conducted) and Heads of the University Departments / Institutions who have so far not paid the aforesaid Examination Fees to the University are required to remit the same urgently on or before November 10, 2020.
